4.6. New Business

4.6.1. Modification Request for RFI 2486

Requested Action: Revise to make it clear that either code "02" or "10" might be appropriate depending on the actual service location.

Reason: This RFI appears to be outdated because it only mentions CMS Place of Service code "02" for telehealth. This could be misleading because there is a newer code "10", which is also valid for use in III02. CMS updated the Place of Service Code Set <"

target="_blank"><https://www.cms.gov/medicare/coding-billing/place-of-service-codes/code-sets>> in 2022 by adding "10" (Telehealth Provided in Patient's Home).

Motion and second to approve adding a reference to code 10 to the RFI 2486 response. Approved.

4.6.2. Modification Request for RFI 1868

Requested Action: Clarify whether ST02 must be an incrementing integer number or if other alphanumeric characters are allowed.

Reason: RFI # 1868 states that an ST02 value of "L25B9JXH!" would be compliant with the TR3. But this appears to contradict RFI # 2308, 2322, and 2329.

Motion and second to approve sending RFI 1868 to the X12N RFI work group for review. Approved.

4.6.3. RFI 2244

Motion and second to approve sending RFI 2244 to the X12N RFI work group for review in conjunction with its review of RFI 1826, other RFIs, and TR3s. Approved.
