X12 reviewed both of the examples provided in the context of X12 version 004010.

Option 1: N4*AUSTELL*GA*301687852*US

Option 2: N4*AUSTELL**301687852*US*SP*GA

The segment comment "A combination of either N401 through N404, or N405 and N406 may be adequate to specify a location." makes option 1 the generally more conventional option. Option 1 eliminates the unnecessary use of the N405 and N406 for many locations through the use of the N402, while option 2 provides the flexibility of supporting state and province codes greater than 2 characters used in other countries. Since segment comments are not part of the actual X12 standard both of the options provided are syntactically correct. Ultimately, because both options are valid which option is used is a decision that must be agreed to by trading partners.
