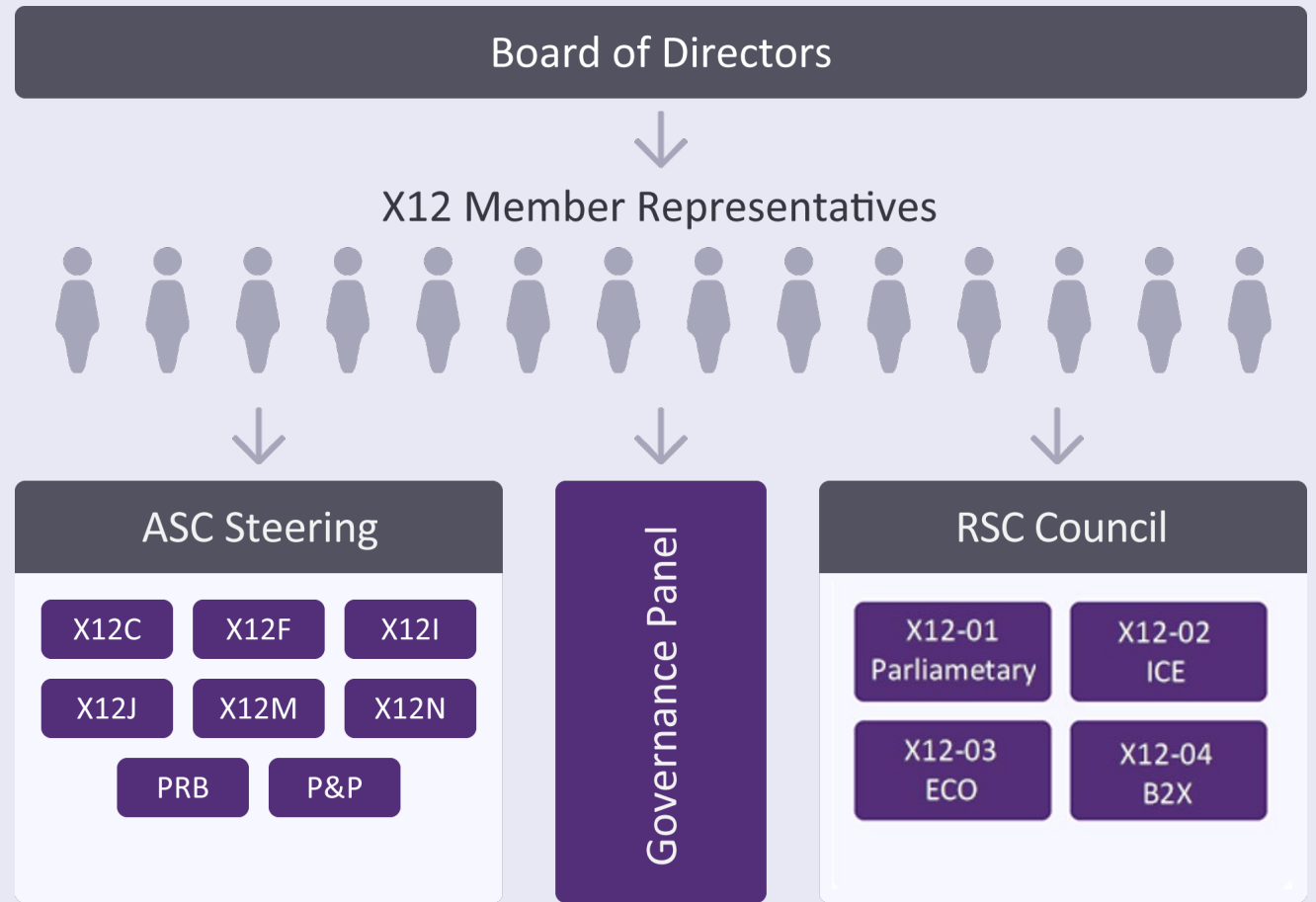

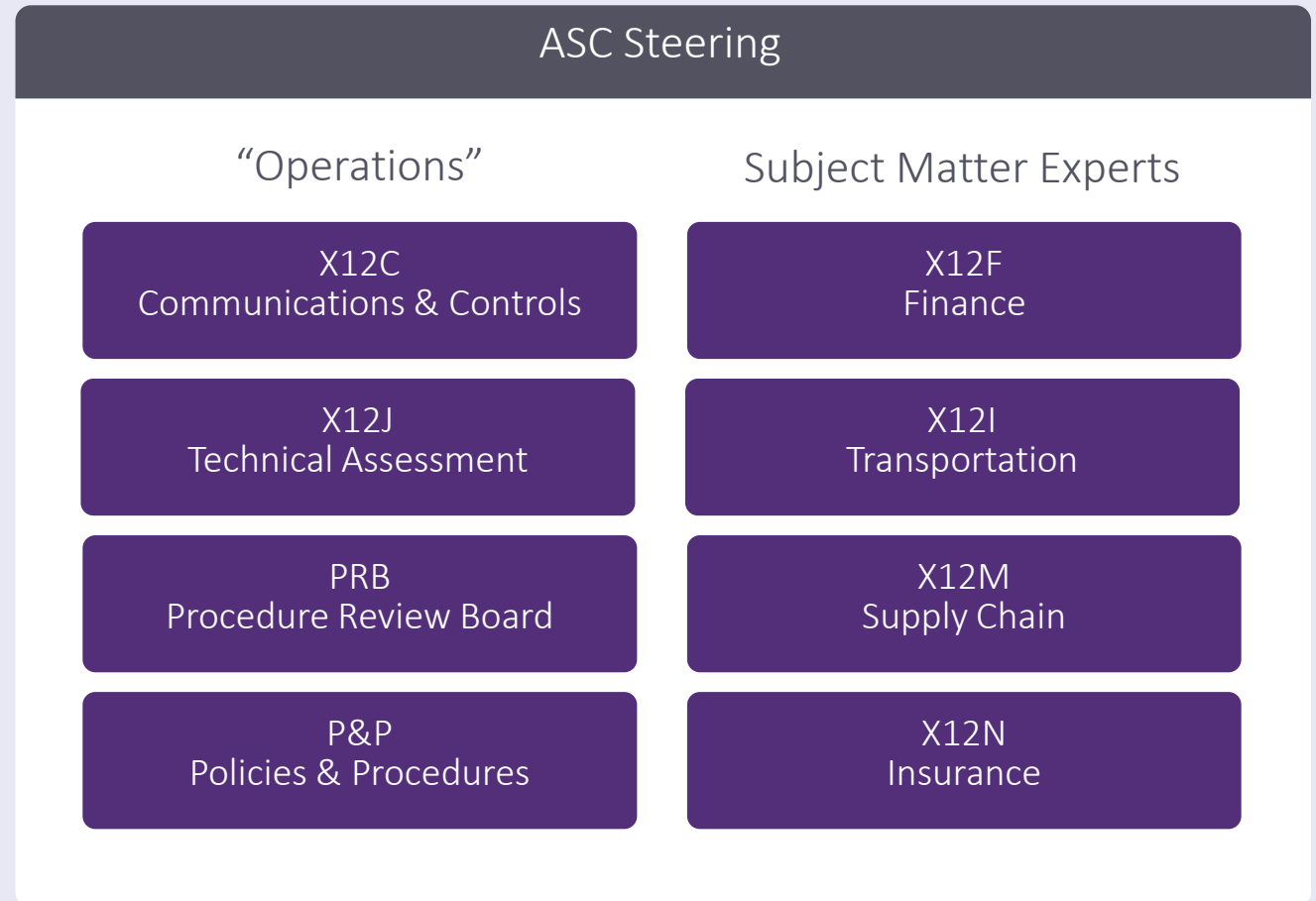

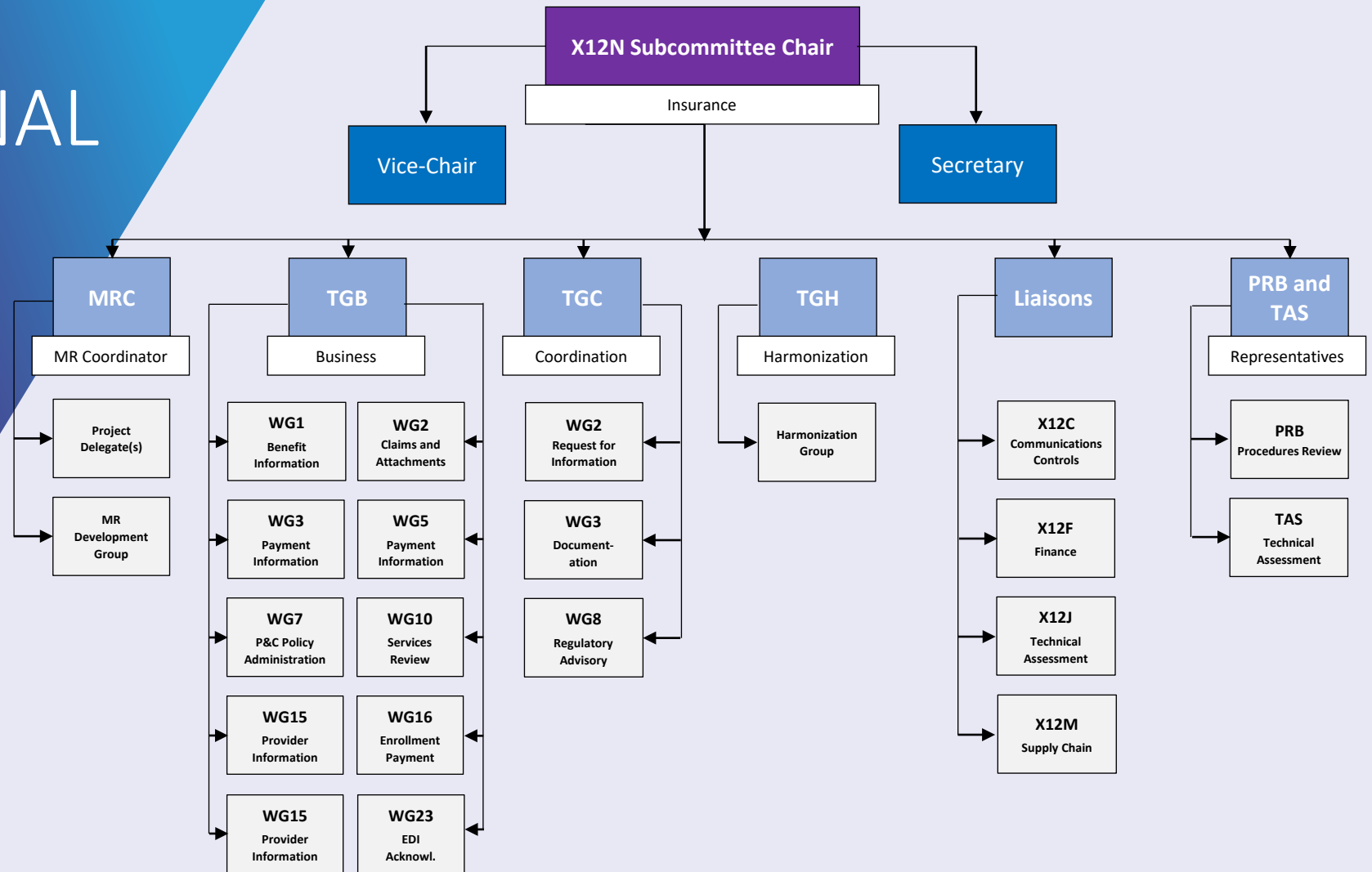
# X12 ORGANIZATIONAL STRUCTURE

# X12N BASICS

- X12N is the Insurance subcommittee
- X12N was established in February 1991
- X12N operates under the ASC
- X12N operates according to a constitution (ASC91) which is posted on [x12.org](http://x12.org)
- X12N defines stakeholder and constituent criteria that must be met before certain privileges, such as voting, are conferred
- X12N's officers, the subcommittee chair and vice-chair, are elected by the X12N stakeholders

# PURPOSE AND SCOPE

- X12N is responsible for the development and maintenance of components of the X12 EDI Standards related to the insurance industry's business activities
  - *Including activities related to property insurance, casualty insurance, health care insurance, life insurance, annuity insurance, reinsurance, and pensions*
- X12N also develops and maintains interpretations, implementation guides, and other technical reports related to its areas of responsibility

# PURPOSE AND SCOPE

- X12N reviews externally-developed products related to insurance business activities. Depending on the review findings, the external product may be formally approved by the ASC or portions of the external product may be included in related X12N-maintained products
- X12N promotes the use of X12 EDI Standards and supporting work products across the insurance industry

# SUBORDINATE GROUPS

- The X12N chair establishes and disbands subordinate groups as necessary to accomplish the work of the subcommittee
- X12N's subordinate groups are classified as a task groups or work groups
- X12N's subordinate groups have a chair or co-chairs designated as officers
  - *In most cases, the subordinate group officer(s) are elected via an electronic subcommittee ballot*
  - *When the subordinate group's officer(s) must have specific experience or skills, the officers are appointed by the X12N chair*

# SUBORDINATE GROUPS

- X12N's subordinate groups may establish a secretary position
- The secretary position is filled as follows:
  - *The subordinate group's chair or one of its co-chairs requests the X12N chair appoint a secretary*
  - *The request usually includes a recommendation of one or more X12N constituent(s) interested in the position*
