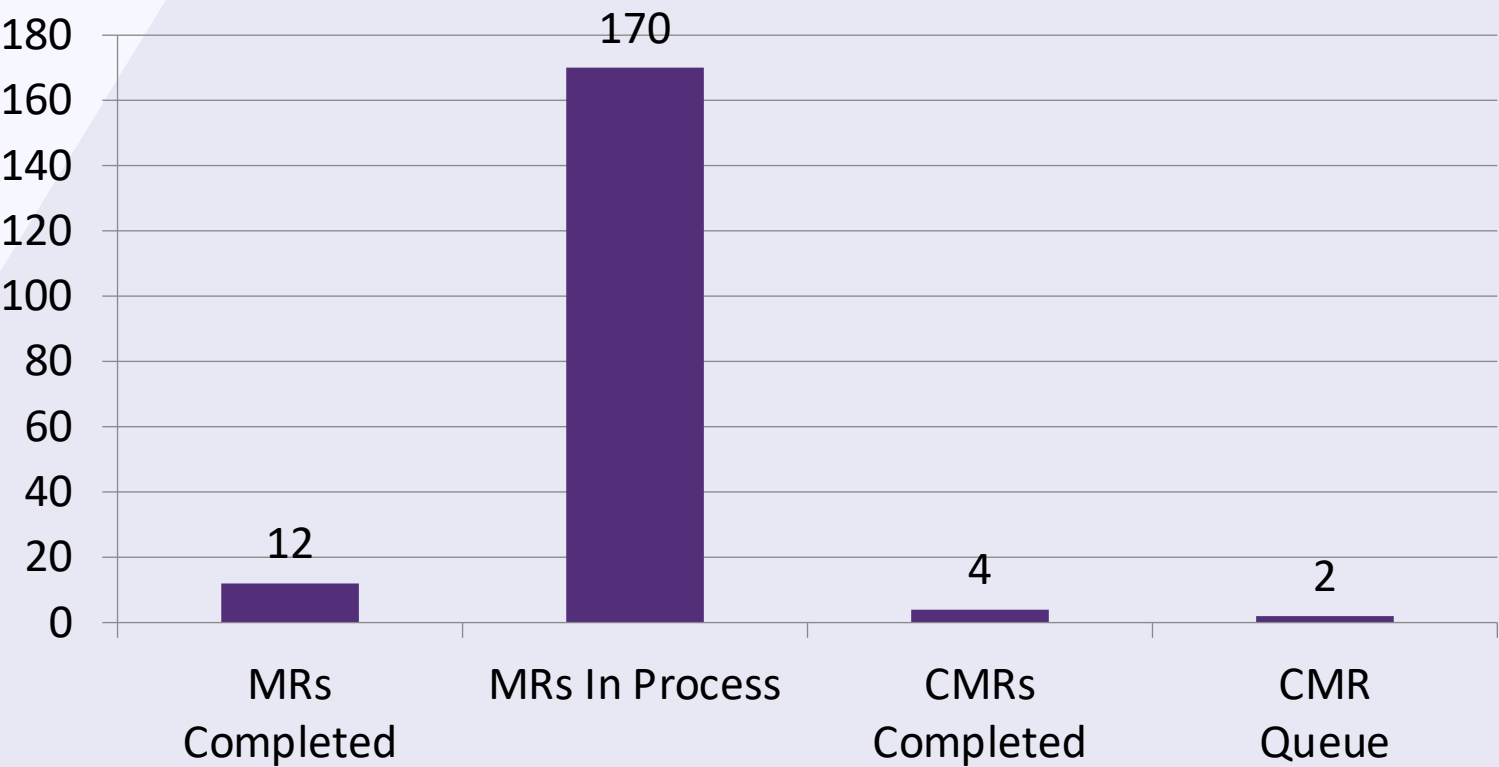

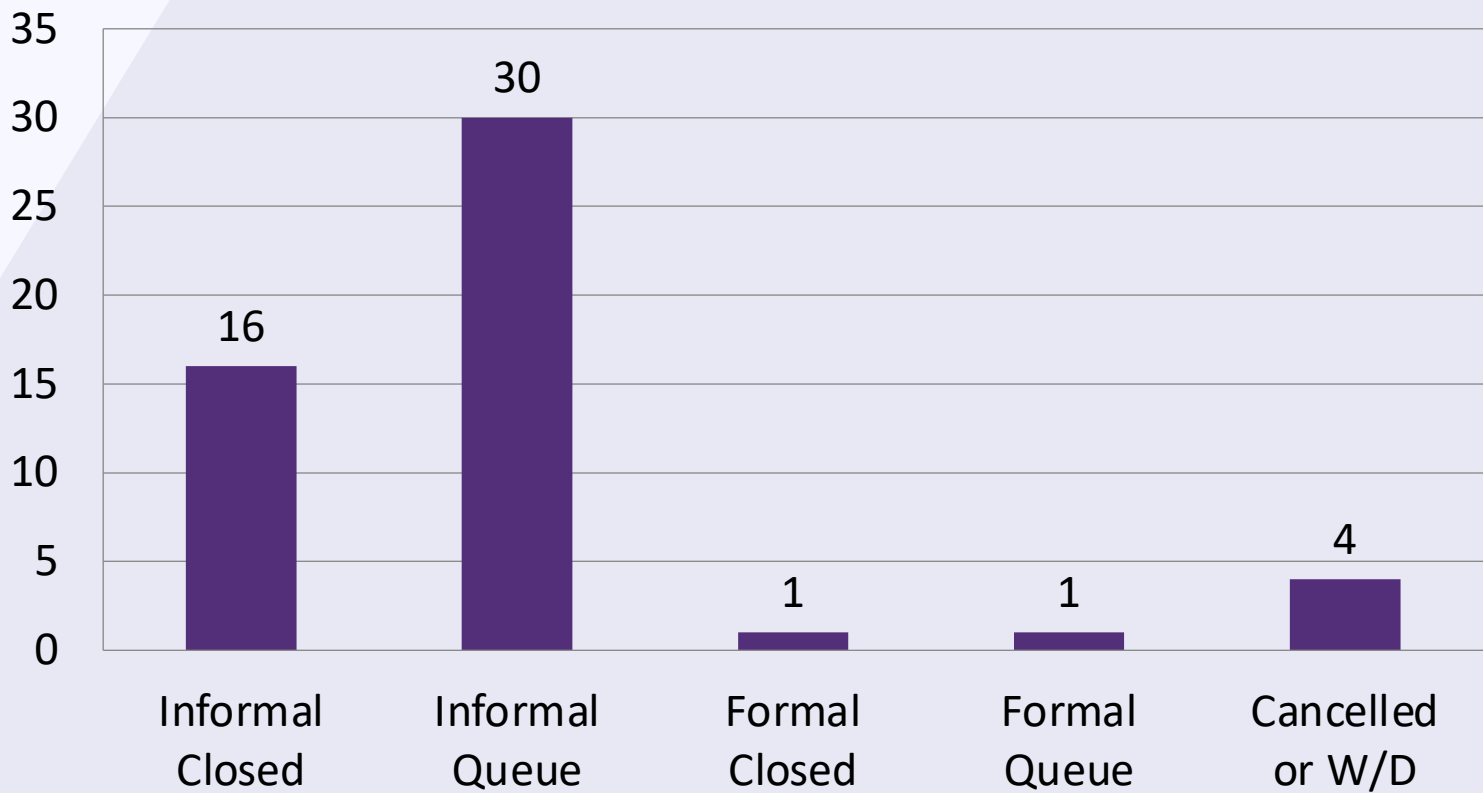

- The third set of recommendations will be submitted after this standing meeting
- X12 continues to respond to questions and gather information to inform the remaining recommendations

OTHER ACTIVITIES

- After several cycles of the ARC MR process operated as a pilot, the ASC is moving the pilot version of ASC02 back into normal operational status
- The ASC has operationalized the electronic election process, providing additional visibility to open positions
- The ASC subcommittees are actively exploring new opportunities in conjunction with the X12 Board

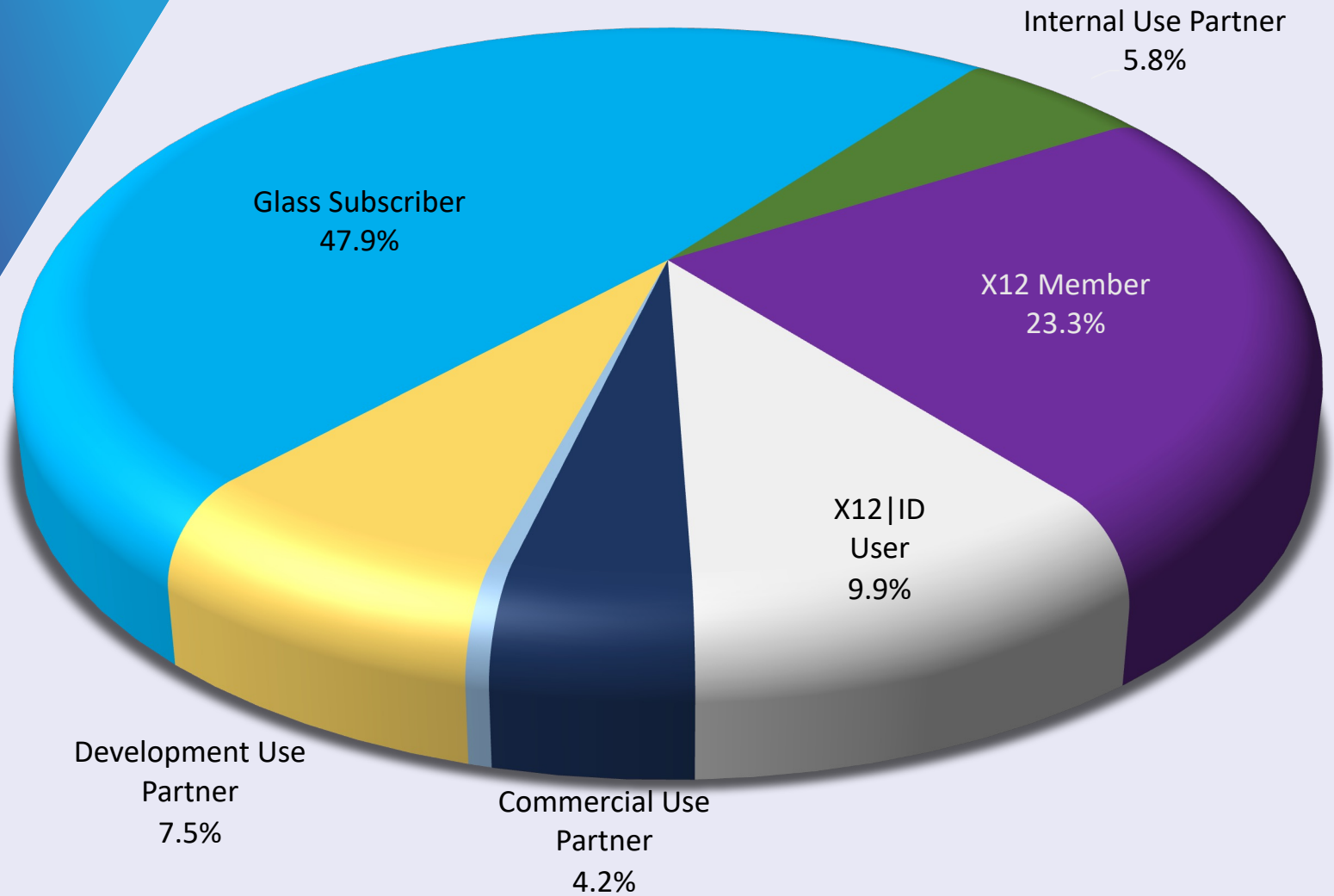

IN THE SPOTLIGHT

INTRODUCTION

IN THE SPOTLIGHT

INDUSTRY NAMES

- Every X12 data element has a name
- Because many data elements are used for various purposes, the data element names can be intentionally general
 - Example: ***NM103 Name Last or Organization Name***
- Having a more specific name in an implementation guide provides clarity that assists implementers
 - Example: ***NM103 Purchaser's Last Name***
- These specific names are identified as Industry Names

IN THE SPOTLIGHT

INDUSTRY NAMES

- On the other hand, data elements that are used very specifically often have a data element name that doesn't need further clarification
 - Example: ***CR104 Ambulance Transport Reason Code***
- In the body of the implementation guide, industry names are labeled so there is no confusion as to whether the name is a data element name or an industry name

IN THE SPOTLIGHT

INDUSTRY NAMES

- To help implementers keep track of data element names, implementation guides include an appendix, specifically Appendix E, that lists all the simple data elements included in the implementation guide
- Industry names are also important in X12's XML schemas because the industry name is the basis of the XML element names
