## CORPORATE MEETING

- → Membership Categories
  - The last change to membership dues was in 2018

Introduced new membership categories
Changed annual dues for some categories

- → The X12 licensing model has grown significantly
- → X12 intends to increase participation and grow membership
- → X12 dues are remaining the same and we are evaluating new paths for participation

# LICENSING UPDATE

- Currently, in discussion with more than
   100 entities regarding licensing
- → To date we have agreements in place with:
  - ~ 90 Commercial Use Licensing Partners
  - ~ 155 Internal Use Licensing Partners
  - ~ 100 Developer Licensees
  - ~ 11,000 Glass and User Licensees

## X12 HIPAA RECOMMENDATION

#### → Update

- X12 has withdrawn it's 2023 recommendation to advance the version of three already mandated transactions:
  - 008030X329 Health Care Claim Status Request and Response (276/277)
  - 008030X333 Benefit Enrollment and Maintenance (834)
  - 008030X334 Payroll Deducted and Other Group Premium Payment for Insurance Products (820)
- X12 intends to modify its initial recommendation, suggesting advancing each of the currently mandated transactions to their counterpart 008060 version

## X12 HIPAA POC STATUS

- → Update
  - New phase focuses on the latest published version of the 270/271 implementation guide

#### X12 - MILESTONES

- → Version 008060 of the EDI Standard was published earlier this year
- → 008060 implementation guides will be in Glass in the coming weeks, starting with the HIPAA-counterpart guides
- → The JSON Proof of Concept project has progressed, the group finalized a specification, and the first release of a supply chain transaction schema is expected soon







#### IN THE SPOTLIGHT

## INTRODUCTION

- In the Spotlight materials are initially presented at an X12 corporate meeting,
- Subsequently, they are posted in the Info Center
- → Each presentation covers one topic
- These "quick hits" highlight new features and functions or remind the audience of things they may have forgotten over time

#### IN THE SPOTLIGHT

## RFI BACKGROUND

- → X12 maintains many standards and related products that are available to the public
- Implementers and other users of X12 products occasionally have questions related to the proper use of the EDI Standard, implementation guides, reference models, or clarification papers
- → These users may ask X12 for clarification by submitting a Request for Interpretation, generally referenced as an RFI
- Sometimes an RFI is referenced more simply as a question or a request

#### IN THE SPOTLIGHT

## RFI BACKGROUND

- → In response to these requests, X12 publishes interpretations explaining how its products are to be implemented and used
- → Interpretations may also result in increased consistency between trading partners
- → Each interpretation is a response to one or more questions posed in an RFI
- → Sometimes the interpretation is referenced more simply as an answer or response

#### IN THE SPOTLIGHT

## RELATED GOVERNANCE

The ASC Request for Interpretation (RFI) Processing Manual (ASCO4) describes the ASC's policies and processes related to RFI's and the associated responses

#### IN THE SPOTLIGHT

#### INTERPRETATIONS

- → An interpretation does not directly result in a revision to an X12 product
- → If the final interpretation illuminates a need to revise an X12 product, the responding subcommittee may submit a corresponding suggestion via X12's maintenance request form
- Regardless of whether the subcommittee submits a maintenance request, the RFI submitter or any materially impacted party may choose to submit a corresponding maintenance request

#### IN THE SPOTLIGHT

### INTERPRETATIONS

- → There are two types of interpretations, formal and informal
- → Formal interpretations represent the official position of the X12 organization
- → Formal interpretations are developed by a subcommittee and approved at several organizational levels before they are final
- → A formal interpretation generally takes more time to finalize than an informal interpretation

#### IN THE SPOTLIGHT

## INTERPRETATIONS

- → Informal interpretations represent the most materially impacted subcommittee's position on the matter
- → Informal interpretations are developed and approved by one subcommittee
- → An informal interpretation is generally published in less time than a formal interpretation

#### IN THE SPOTLIGHT

# MODIFYING AN INTERPRETATION

- → Over the course of time, X12 may need to revise (change) or retract (invalidate) a published interpretation
- X12 has a process for when such a modification is warranted



#### IN THE SPOTLIGHT

### **SUMMARY**

→ Supporting RFIs

Provides implementers and other materially impacted parties the opportunity to better understand the intentions of X12's subject matter experts

Provides X12's subject matter experts with perspectives they might not otherwise understand

Interpretations are an important tool in X12's arsenal
