IN THE SPOTLIGHT

X12'S POLICIES & PROCEDURES

- X12's policies and procedures are consistently named and formatted
- X12's policies and procedures are hierarchical, corresponding with the organizational structure
- Corporate policies and procedures are overarching, they apply to all X12 committees, subcommittees, and other subordinate groups
- Corporate policies and procedures begin with "CAP"



IN THE SPOTLIGHT

- Committee policies and procedures apply to all the subcommittees and other subordinate groups operating within the committee
- Committee policies and procedures begin with “ASC” or “RSC”
- Subcommittee policies and procedures apply to all subordinate groups within the subcommittee
- Subcommittee policies and procedures begin with the committee’s prefix with each subcommittee having a specific numeric range identifying its specific governance

IN THE SPOTLIGHT

- Depending on the establishing group's policy, a subordinate group may be permitted to establish policies and procedures
- When permitted, subordinate group policies and procedures apply only to that specific subordinate group
- Subordinate group policies begin with the committee's prefix and are numbered within the subcommittee's specific numeric range



IN THE SPOTLIGHT

- A policy or procedure established by a lower-level group supplements a higher-level policy for that group
- However, a policy or procedure established by a lower-level group cannot countermand, contradict, or overrule a higher-level policy
- A lower-level policy or procedure can be more restrictive than the associated higher-level policy but not more permissive
- Some policies explicitly forbid lower-level policies

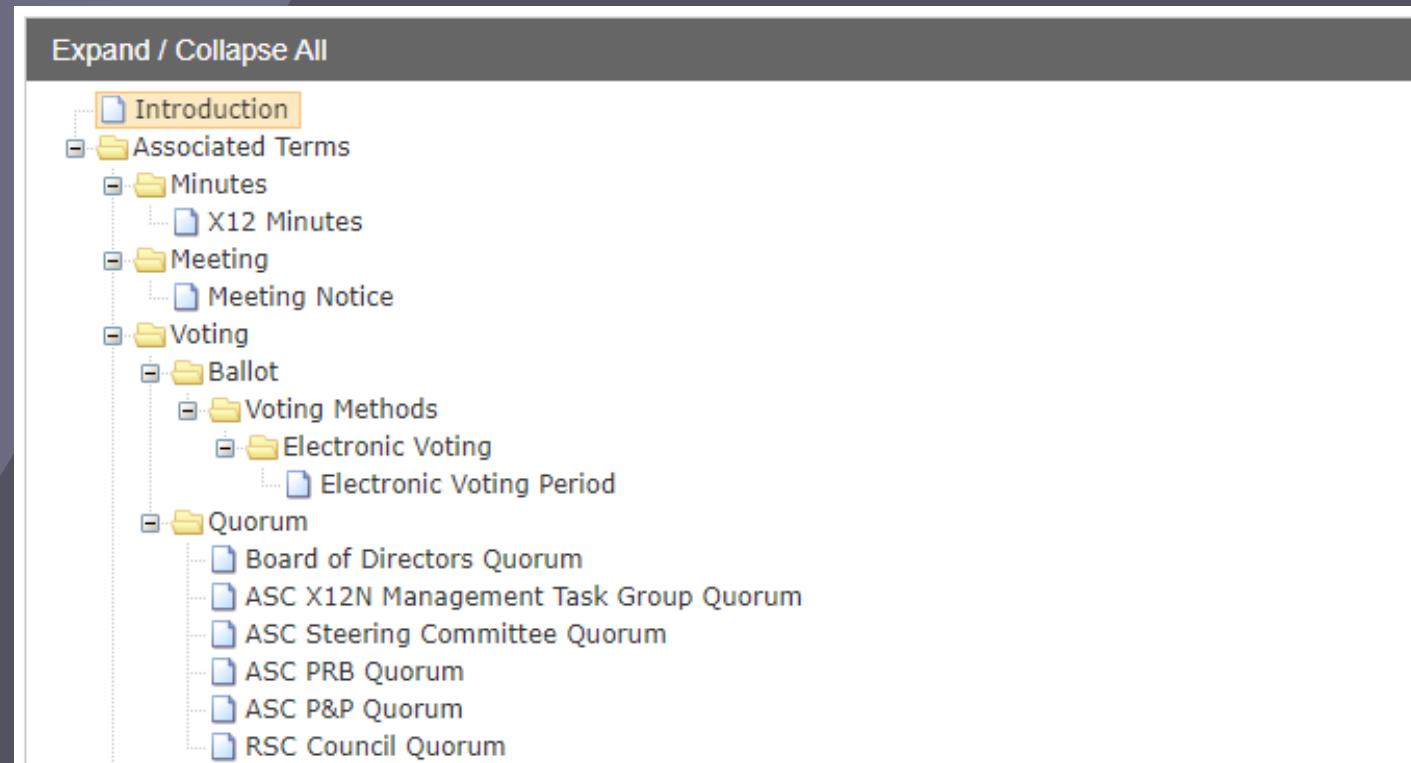


IN THE SPOTLIGHT

- The Board established the Governance Panel to assist with maintenance of the corporate policies and procedures
- The ASC and RSC committees have established subordinate groups responsible for policies and procedures
 - ASC - the Policies and Procedures Task Group (P&P)
 - RSC - the Parliamentary subcommittee
- Some policies are included in the X12 Wordbook, providing an easy quick reference
