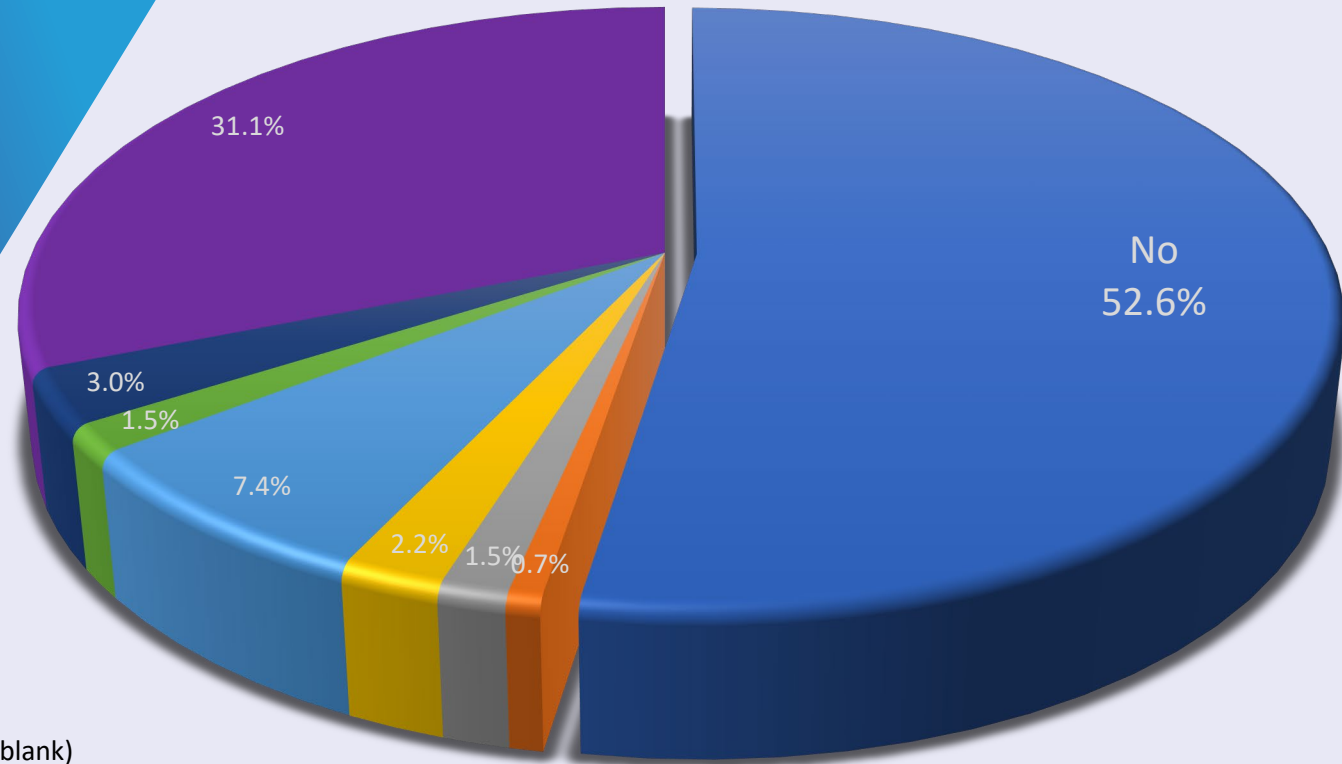

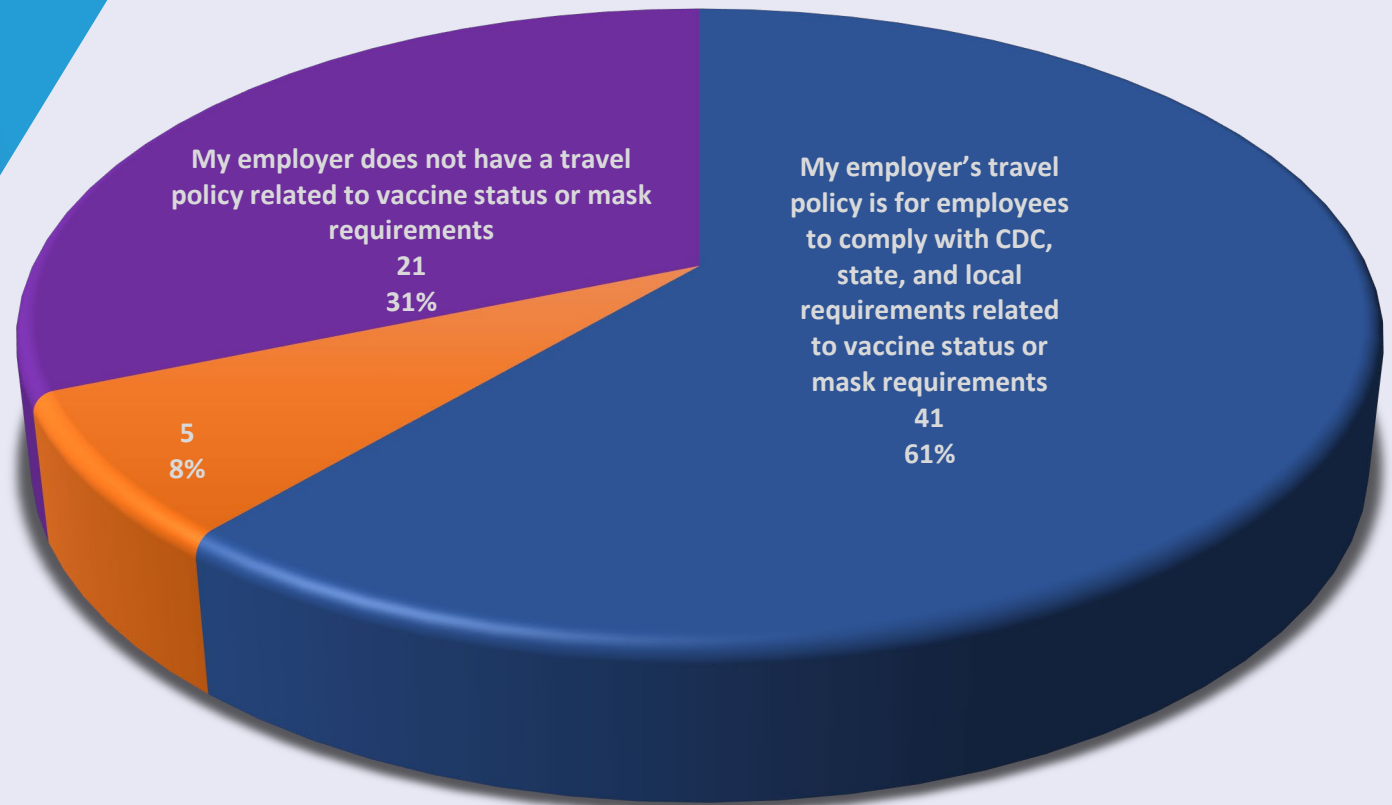

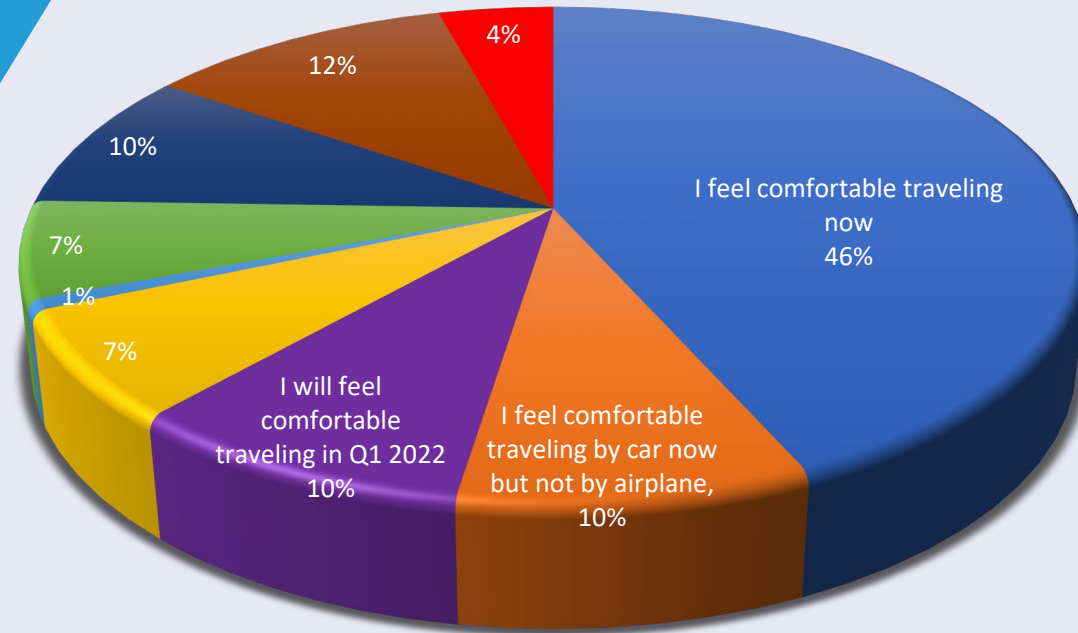

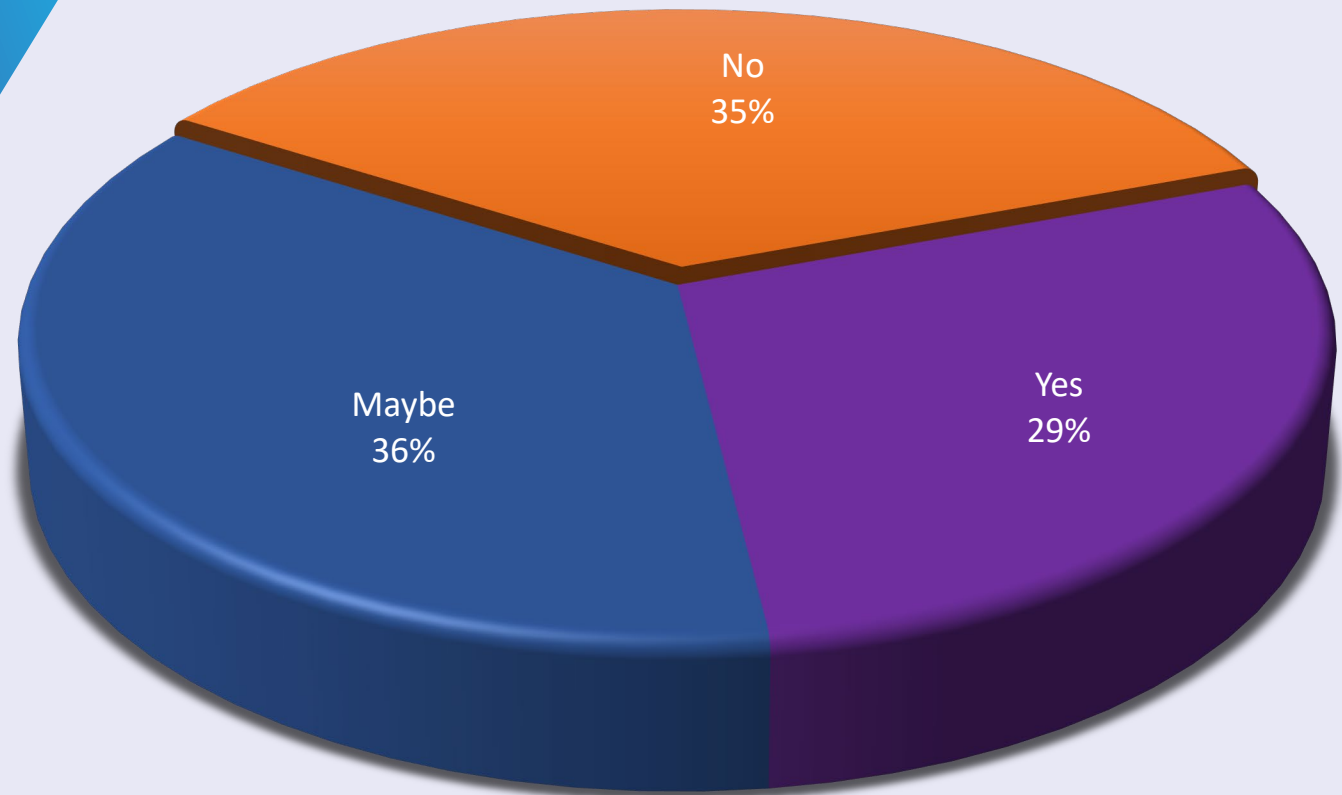

BUSINESS TRAVEL?

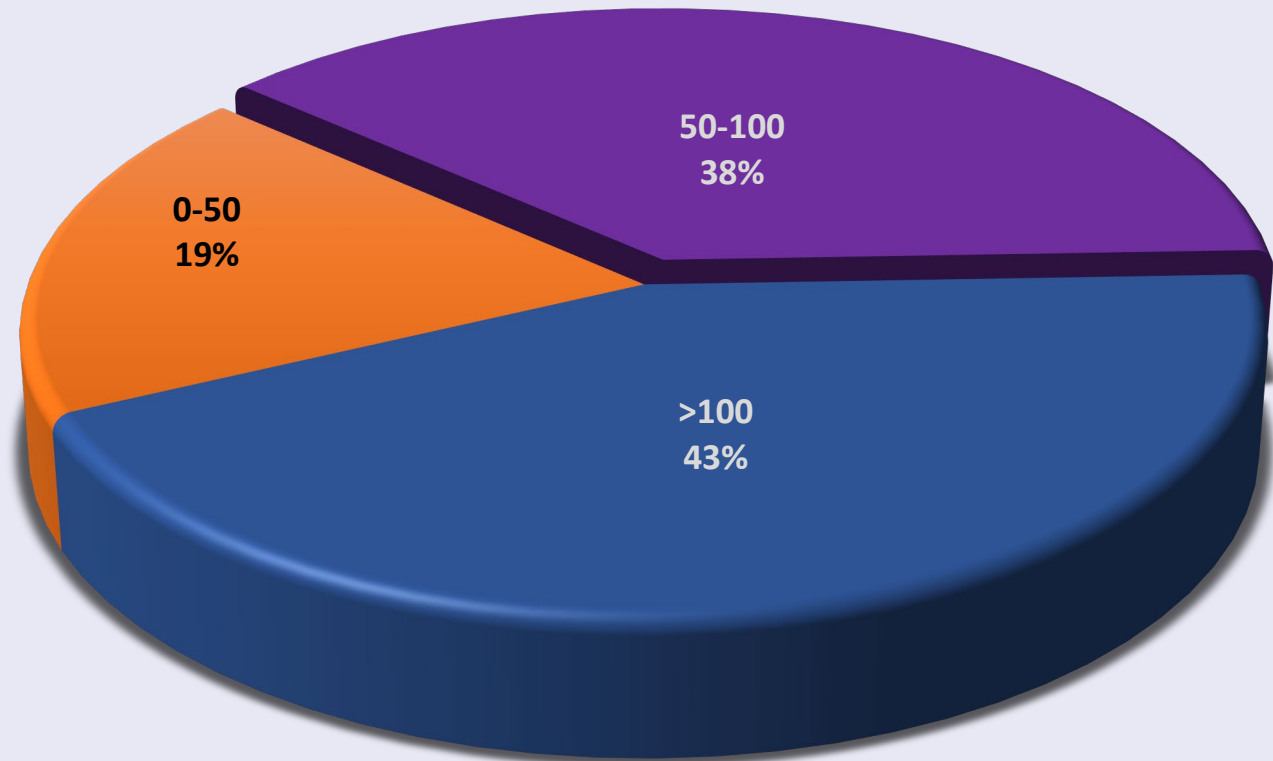


- I will feel comfortable traveling in Q2 2022

- *100% vaccination status of all the attendees and full masking*
- *A mandate that all attendees must provide proof of vaccination*
- *Being that COVID is airborne I'd like to see that hotels are using devices to clean the air in every conference room and also in the hotel rooms. Some hotels are not cleaning rooms daily- I'd support that but want to be assured my room was thoroughly cleaned upon arrival.*
- *Case numbers in the areas. Doesn't need to be zero but needs to be better than what we saw in late Aug and early Sept with Delta Variant going around.*

## ARE YOU PLANNING TO ATTEND THE SCHEDULED WINTER 2022 STANDING MEETING IN PORTLAND, OR?

### No . . .

- *I do not plan to attend any X12 meetings in person anymore since virtual attendance works fine and I do not lose so much time with traveling.*
- *I don't want to put myself or my children at risk for covid.*
- *We suggest Winter 2022 be scheduled as a Hybrid meeting to accommodate companies such as ours.*
- *My subcommittee is unsettled by the unrest in Portland especially the area in the immediate surroundings of the hotel.*
- *At the present, not sure it is the same city from two years ago, 2019, and would suggest if we could find another location on the West Coast like CA (we did this many years ago in San Diego). CA in September/October is ideal*

# SUMMARY OF 135 RESPONDENTS TO THE SURVEY:

46% are comfortable with air travel now

53% do not have a travel ban in place

96% optimistic about travel in the future

29% said "Yes they would attend"

36% Said "Maybe they would attend"
