	<p>Response 1: Comment 1 response: Appendix B.1.1.2.2 restricts the maximum length of Data Element Number 782 to 10 digits for all guides and does not need to change.</p> <p>Ref1 response: The Loop 2200B AMT02 is Data Element 782 and is subject to the Appendix B.1.1.2.2 maximum length restriction of 10 digits (even if the Appendix B.1.1.2.2 Data Element Note is not present). A Data Element Note is needed clarify the Data Element 782 maximum length restriction of 10 is not applicable for the Loop 2200B AMT02 Total Accepted Amount Data Element.</p> <p>Ref3 response: This MR was created when only version 8020 of X330 was available (version 8030 had not yet been published). The work group is unable to comment regarding what MR resulted in version 8030 to no longer reflect the Appendix B.1.1.2.2 Data Element Note.</p>
	<p>Comment 2: CMS does not agree with expanding X330 2200B Amount total. Why would you acknowledge an amount larger than you can actually send?</p>
	<p>Response 2: Loop 2200B AMT Total Accepted Amount reports the total accepted dollar amount for an 837 transaction set (i.e., 837 batch of claims) and not an individual claim. This change was initially approved for version 7030 as a result of a request made by the industry because the total claim or encounter charge amounts in an incoming ASC X12 837 transaction set can be greater than the 10 digits allowed.</p>
