DE 352: Increase maximum length

Comment 1: We disapprove of MR #399 asking to replace DE352 with
DE933 in the PWK segment. Functionally, this request asks to allow for
free text up to 264 characters instead of 80 characters. We recognize
that allowing for more characters could enable greater transparency in
the 277 response. However, we are concerned that increasing the
allowable characters in the PWK segment could further enable payers
to inappropriately leverage the 277 to issue denials instead of using the
835. The effective issuance of a denial in the 277 eliminates the formal
denial process and with it the ability to appeal. Moreover, such use of
the 277 can skew the tracking of plan metrics. Therefore, we urge
caution in moving ahead with this request.
Response 1: Thank you for your comment.
Comment 2: Allowing more unstructured, free-text data will be added
burden on the providers to review and determine the actions they need
to take. Codification of the information needs to be maximized to
automate the workflow.
Response 2: Thank you for your comment. This MR expands the
available free text characters.
Comment 3: MSG existed in the 5010 at claim and line level. Why not
restore as that was already in place and has been coded to pick up the
MSG segments instead of moving to PWK and increasing the PWK
size?

DE 352: Increase maximum length

Comment 4: Based on the business case, changing the data element in order to extend the maximum length to support reporting a rejection that cannot be codified does not comply with the 2210DB PWK07 Situational Rule. The 2210DB PWK07 situational rule states "Required when a non-standard or free form message is necessary to supplement or enhance the status information reported in the 2200D STC."

Additionally, when a rejection cannot be codified, a new Claim Status Category/Claims Status Code must be requested. This is supported via the 2210DB PWK segment note referencing Section 1.4.3.1 - STC Composite and Code Use Rules where it states "When the current Health Care Claim Status Category Codes or Health Care Claim Status Codes do not meet the Information Source's specific business need, a request for a new or modified code must be submitted for industry use. See Section 1.4.3 regarding code modifications."
